Prospective tenderers are advised to get register themselves at NIC CPP portal, obtain 'Login ID' & 'Password' and go through the instruction available in the Home Page after log into the CPP-portal http://etender.gov.in/eprocure/app. They should also obtain Digital Signature Certificate (DSC) in parallel which is essentially required for submission of their tender.

The tenderer shall submit their tender only at CPP portal https://etender.gov.in/eprocure/app. Tenderer/Contractor are advised to follow the instruction provided in the tender document for online submission of bids. Tenderers are required to upload the digitally signed file of scanned document along with scanned copy of Demand Draft for Tender Fee& EMD.

Uploading of tender in location other than specified above shall not be considered. Hard copy of tender shall not be entertained.

1. The tenderers shall be required to submit the bids in two-envelopes.

A. <u>e-Envelope 01</u>:- <u>Eligibility Criteria</u>-Will contain digitally signed file of scanned document of all the following:

Signed and scanned copy of whole tender document to be uploaded.

Should have satisfactorily completed the works as mentioned below during the last two years ending up to previous day of last date of submission of tenders.

(i) Two similar works each costing not less than Rs. 6 Lakhs

(or)

- (ii) One similar work costing not less than Rs.8 Lakhs
- a) Documents for Earnest Money and Tender Fee (Separate demand drafts in favour of School of Planning and Architecture, Vijayawada, payable at Vijayawada) specified as above only.
 - i. The original Demand Draft against Earnest Money and tender fee should reach by post/courier/given in person to the concerned officials as mentioned in CRITICAL DATE SHEET. Any postal delay will not be entertained.
 - ii. The details of Demand Draft physically sent, should tally with the details available in the scanned copy and data entered during bid submission time, failing which the tender shall be rejected.
 - iii. <u>It should be denominated in INDIAN RUPEES only. Bids without requisite</u> Earnest Money shall be summarily rejected.
 - iv. However firms registered as MICRO and Small Enterprises (MSEs) as defined in MSME procurement policy may be exempted from paying the EMD/bid security. To claim the exemption, the bidders must be providing relevant documents themselves.
 - b) GST registration certificate.
 - c) PAN card
 - d) OEM Authorization letter.
 - e) The Bidder should be a registered company in India as per Companies Act 1956. The certificate of incorporation issued by Registrar of Companies along with copies of Memorandum of Articles of Association are required to be submitted along with technical bid.
 - f) Should have IT returns in last three financial years (2018-19, 2017-18 and 2016-17), and details to be scanned and uploaded.

The financial bids of the Supplier/firms found to be meeting the qualifying requirements (Eligibility Criteria) shall be opened as per **CRITICAL DATE SHEET.** (**Depending on Technical Bid evaluation, the date shall be intimated through CPP Portal). Financial bid/Price bid of tenders will not be opened and offer will be treated as cancel in case e-Envelope - 1 are not found in order.**

B. e-Envelope-2: Financial e-bid through CPP Portal:-

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit online, without changing the file name. If the BOQ file is found to be modified by the bidder, the bid will be rejected. If the BOQ file is given in pdf format than bidders will download the same, fill the rates, complete it and will attach in the same format after signing.



- 2. Tenderers must ensure that all the uploaded documents should be of good quality. Vague /poor quality of printed documents and incomplete documents will not be accepted.
- 3. The rates quoted by the Tenderers/vendors should be inclusive of GST.
- 4. The rates of all items to be provided in e-tender, rate quoted as zero for any item will be liable for rejection of financial bid. Conditional tenders shall also be liable for rejection.
- 5. The Director, SPAV reserve the right to verify the credential submitted by the agency at any stage (before or after the award of software). If at any stage, any information /documents submitted by the tenderer is found to be incorrect/false or have some discrepancy which disqualifies the contractor then the following actions are liable:
 - a) Forfeit the entire amount of EMD submitted by the firm.
 - b) The agency shall be liable for debarment from tendering in SPAV, apart from any other appropriate contractual/legal action.

The Director, SPAV reserves the right of accepting or rejecting any or all tenders or any part thereof without assigning any reason.

The Tenderers are required to submit digitally signed eligibility criteria of the conditions such as software orders of similar nature with completion certificate/certified bills indicating the value of software specified as above, GST registration certificate, PAN card etc,

- 1) Estimated Cost of the software is Rs. 1,00,170.00 (for market rates.
- 2) The software support, update and maintenance should be carried out at time to time by the awarded organization with proper intimation to SPAV.
- 3) The tender shall not be issued physically. The tendering process is online at NIC CPPP e-portal URL address http://etender.gov.in/eprcure/app. Tenders should submit tender fee of Rs.500/- (Rupees Five Hundred Only) in DD in favour of "School of Planning and Architecture, Vijayawada, payable at Vijayawada" (non-refundable) for tender cost.
- 4) The earnest money amounting to **Rs. 2,004.00** (**Rupees Two Thousand and Four Only**) as Demand Draft or pay order of a schedule bank drawn in favour of "School of Planning and Architecture, Vijayawada," payable at Vijayawada should be scanned and attached on Eportal. However, the original Demand Draft against Earnest Money and Tender Fee(as Demand Draft or pay order of a schedule bank drawn in favour of "School of Planning and Architecture, Vijayawada," payable at Vijayawada) should reach by post/courier/given in person to the concerned officials as mentioned in CRITICAL DATE SHEET.
- 5) The Employer does not bind himself to accept the lowest or any tender and reserves to himself the right of accepting the whole or any part of the tender and the Tenderers shall be bound to perform the same at the rates quoted.
- 6) Canvassing in connection with the tenders is prohibited and the tenders submitted by the Supplier who resort to canvassing are liable for rejection.
- 7) The Tenderers shall not be permitted to tender for software in the concerned unit of SPAV in which a relative is posted in any grade between The Registrar and -----. He shall also intimate the names of persons who are working with him in any capacity or subsequently employed by him and who relatives are as mentioned above.

Note: A person shall be deemed to be relative of another if, and only if, They are members of a Hindu undivided family; They are husband and wife; or The one is related to the other in the following manner: Father, Mother (Including step mother), Son (Including step son), Son's wife, Daughter (including step daughter), Father's father, Son's son, Son 's son's wife, Son's daughter, Son's daughter's husband, Daughter's husband, Daughter's son, Daughter's son's wife, Daughter's daughter, Daughter's and daughter's husband, Brother (Including step brother), Brother's wife, Sister (including step sister), Sister's husband.

- 8) Tender submitted shall remain valid for 90 days from the date of opening for the purposed of acceptance and award of software, validity beyond 90 days from the date of opening shall be by mutual consent.
- 9) The Tenderer shall quote rates both in figures and words. He/She shall also work out the amount for each item of software and write in both figures and words. On check, if there are



differences between the rates quoted by the Tenderer in words and in figures or in the amount worked out by him, the following procedure shall be followed:

When there is a difference between the rates in figures and in words, the rates, which correspond to the amounts worked out by the Tenderer, shall be taken as correct. When the Tenderer does not software out the amount of an item or it does not correspond with the rate written either in figures or in words, the rate quoted by the Tenderer in words shall be taken as correct. When the rate quoted by the Tenderer in figures and in words tallies but the amount is not worked out correctly the rate quoted by the Tenderer shall be taken as correct and not the amount. When no rate have been quoted for any item (s), leaving space / coulombs both in figure & software and amount unfilled, it will be considered that the tenders has included cost of the item in thither items and rate for such items will be treated as "Zero" and software will be required to be executed accordingly.

- 10) The Tenderer should see drawings and in case of doubt obtain required particulars, which may in any way influence his tender from the person as no claim whatsoever will be entertained for any alleged ignorance thereof.
- 11) Earnest money shall be forfeited if the supplier fails to commence the installation of software as per letter of award. If any Tenderer withdraws this tender within the validity period or makes any modification in terms and condition of the tender which are not acceptable to the Department, then SPAV shall without prejudice to any right or remedy, be at liberty to forfeit 50% fifty percent) of the earnest money absolutely.
- 12) Except writing rates and amount, the Tenderer should not write any conditions or make any changes, additions alterations and modifications in the printed form of tenders. Tenderers who are desirous to offer rebate, the same should be brought out separately in the covering letter and submitted along with the tender.
- 13) Some of the provisions of General Conditions of Contract are given below. Interpretation however shall be as given in the General Conditions of the supply and installation of both software.
- 14) Performance Security: Successful bidders shall submit a Performance Security of 10% of the cost of the Software within 15 days of the placement of purchase order. The Performance Security should be in the form of Bank Guarantee by any Indian Nationalized Bank. The Bank Guarantee should be valid for one year. In case, supplier either fails to deliver the items within delivery period or do not provide satisfactory maintenance service during the warranty period, the Performance Security submitted by the firm is liable to be forfeited. Performance Security shall be released immediately after one year. No interest will be paid by SPAV on the Performance Security Deduction of Income Tax and Labour cess at the prevailing rate shall be made from the running and final bills of the software.
- 15) The supplier shall quote their rates inclusive of all applicable Taxes and Duties, GST etc.
- 16) Warranty / Guarantee: Bid must be quoted with a on-site warranty / guarantee which will commence from the date of the satisfactory installation / commissioning of goods, against the defect of any manufacturing, workmanship and poor quality of the components/software.
- 17) Only manufacturer(s) or their sole authorized distributor /agent are eligible to bid. Authorization letter from Original Software Manufacturer (OEM) in favour of authorized Agent to bid / negotiate / conclude the order against this tender must be enclosed with technical bid.
- 18) Delivery & Installation: All the goods ordered should be delivered & installed within 15days from the date of issue of the purchase order. All the aspects of safe delivery, installation and commissioning shall be the exclusive responsibility of the supplier. If the

supplier fails to deliver, installation and commissioning of the goods on or before the stipulated date, then a penalty at the rate of 1% per week of the total order value shall be levied subject to maximum of 10% of the total order value

GENERAL TERMS & CONDITIONS

- A. The bids should be uploaded in https://eprocure.gov.in/eprocure/app. Please follow the guidelines of the site.
- B. The supplier has to quote his best competitive price considering all the factors. The price shall be inclusive of all type of taxes, duties, statutory labour liabilities etc, all complete. No escalation on any account shall be admissible during the currency of contract.
- C. The Director, SPAV, reserves the right to cancel any or all the tenders without assigning any reason.
- D. The suppliers shall be responsible for any damage to the Software caused due to faulty operation/poor servicing/mishandling etc. by their staff and shall rectify the defects free of cost. Decision of the in charge Maintenance, SPAV, shall be final in this matter.
- E. Any other small items of repair/replacement not specified in the contract shall be got done by the supplier.
- F. Validity of Tender: Ninety days from the date of opening of tender. During this period no bidder shall be allowed to withdraw his tender. In case of withdrawal, the EMD submitted by the bidder shall be forfeited and no claim shall be entertained on this regard.
- G.
