3. ITEM # 3a: To consider and recommend the Course Structure for the PG programme of Master of Planning (Environmental Planning and Management) as approved and recommended by the Board of Studies – Planning in its Fourth Meeting held on July 16, 2012 at SPA Vijayawada.

On request of the Chairman, the HOD–Planning informed the members that the title of the M.Planning courses were approved by the AC in its Second Meeting and the BOG in its X Meeting. Thereafter the course structure and detailed syllabus of one of the courses - M.Planning (Environmental Planning and Management)" has been approved by Board of Studies-Planning in its Fourth Meeting held on July 16, 2012. In this regard, he mentioned that the matter has been deliberated extensively, involving several steps as summarised below:

- i. In the <u>BOS-Planning's First Meeting held during October 29-30, 2010</u>, the start of two Masters programmes in Planning, namely "<u>Infrastructure Planning & Management"</u> and <u>"Environmental Planning & Management"</u> was proposed (vide Item#6, Ist Meeting Minutes).
- ii. In continuation, the Dept of Planning held its first "Expert Committee Meeting M.Planning" on Nov 22, 2010 to discuss the Masters programme in detail. The Expert Committee had eminent representations from CEPT Ahmedabad (Infrastructure experts), SPA Delhi (Environmental experts), JNTU-Hyderabad (Infrastructure experts), MMRDA (regional planning experts), World Bank (Infrastructure experts), HMDA (city planning experts), private sector, etc.
- iii. In continuation, in the Second Academic Council Meeting on July 29-30, 2011, the two PG programmes were approved and recommended (vide resolution 8). Thereafter, the BOG, in its X Meeting (5 Aug 2011), approved two the PG programmes, 'M.Planning (Infrastructure Planning & Management)' & 'M.Planning (Environmental Planning & Management) (vide Resolution No 46).
- iv. The course structure and detailed syllabus of both the two M.Planning were discussed in detail in the form of Brainstorming Sessions in the Third Meeting of BOS-Planning held on Nov 25, 2011. The meeting had eminent representation from CEPT-Ahmedabad, JNU-Delhi, Academic Council SPAV members, IIT-Kharagpur, SPA Delhi, etc.

In the Fourth Meeting of BOS-Planning held on July 16, 2012, the updated Course Structure and Detailed Syllabus of one of the PG programmes - M.Planning (Environmental Planning & Management) was presented and discussed. The meeting had eminent representations from JNU-Delhi and IIT-Ropar among others. The BOS-Planning approved and recommended for the AC (Resolution 10 & 11).

Several course structure from other institutions in the country and abroad were referred to pick up the positive elements from each and develop an edge. Salient features of the approved Course Structure & Detailed Syllabus of M.Planning (Environmental Planning and Management) are:

The first semester is a foundation semester, introducing the key aspects of planning, environment, spatial and statistical analysis, etc. Second and third semester are specialisation semesters (focusing on core aspects of environmental planning & management) with electives for advanced study. Final semester shall be on focussed on thesis.

B. In first three semesters, maximum number of written end exams are limited to TWO subjects each (including electives). In the fourth semester, maximum number of written end exams is limited to only ONE.

C. Five underlying principles of 'Sustainability, Equity, Efficiency, Harmony, and Safety' are to be emphasized as a cross-cutting theme in executing planning studio exercises and application of theory.

In the execution of the subjects and studios, the aspect of transforming plan proposals into project formulation, D. project planning, project financing schemes and project documentation should be inculcated.

For each theory subject taught, there has to be a strong emphasis of relating the same with live and documented E. environmental concerns at particular scales of settlements.

The assessment strategies of the different subjects should emphasise the development of strong communication, interpersonal, advocacy and analytical skills. Assessment is to be taken up through alternate modes namely through seminars, debates, group/individual presentations, term papers, written exams (open or closed book), take home exams, report submissions, viva voce etc.

In this regard, the BOS-Planning IV resolved as follows -

Resolution # 10: The Board of Studies in Planning unanimously resolves to approve and recommend the Proposed Revised "Course Structure for the two year Masters Degree in Planning (Environmental Planning and Management)" as presented in Annexure: III herewith, for the consideration and recommendations of the Academic Council.

On request of the Chairman, the HOD–Architecture informed the members that the title of the PG courses in Architecture were approved by the AC in its Second Meeting as "M.Arch (Conservation), M.Arch (Energy & Sustainable Architecture) and M.Arch (Coastal Habitat)". Thereafter, in the BOG X Meeting, after deliberations, the tiles were approved as 'Master in Architectural Conservation'; 'Master in Energy and Sustainable Architecture' & 'Master in Coastal Habitat Architecture' (vide Resolution No 45).

The BOS-Architecture III has noted the above resolution by BoG. However, to aid clarity in the course content, the BOS-Architecture III has further recommended the title of the programme as "Master in Energy Efficient and Sustainable Architecture", vide agenda item no. 5 of the Minutes of BOS-Architecture III held during Oct 11-12, 2012 and resolved as below -

<u>Resolution # 06:</u> The BoS-Architecture unanimously resolves to approve and recommend the proposed Course Structure for the PG programme in Architecture leading to the award of 'Master of Energy Efficient & Sustainable Architecture'.

In this regard, the AC members noted the resolution of the BoG and BoS-Architecture and after detailed discussions observed that the nomenclature of the PG programme should remain as **M.Arch (Sustainable Architecture)**, and only B.Arch graduates to be eligible for admission. Accordingly, the AC unanimously resolves on this aspect as follows:

Resolution # 14.

The Academic Council unanimously approves and recommends the title of the PG programme in Architecture to be "M.Arch (Sustainable Architecture)", for re-consideration by BoS-Architecture and subsequent approval of BoG, subject to only B.Arch graduates eligible for admission.

HOD-Architecture mentioned that the Course Structure and Detailed Syllabus has evolved after two Core-Committee Meeting and BOS-Architecture Meeting III. After detailed discussions, the following suggestions were made by the AC:

7. ITEM # 5:

To consider and approve the "Equivalence Course Structure and Regulations for B.Planning Students" following old SPA Delhi Course Structure who failed to clear academic requirements and are required to attend classes with batches where new SPA Vijayawada Course Structure (initiated since 2011-12 A.Y.) are followed.

On request of the Chairman, the HOD–Planning informed the members that in its Second Meeting held on December 15, 2010 at the Hotel Golkonda, Hyderabad had finalised the new course structure, detailed syllabus and academic regulations for the four year undergraduate programme - Bachelor of Planning. Thereafter, the matter was discussed in the Academic Council Meeting II held on July 29-30, 2011 at SPAV Vijayawada wherein the members recommended for approval of the BOG. Thereafter, the BOG on its Xth Meeting held on 05 Aug 2011, resolved that the revised Course Structure and Detailed Syllabus of the 4-Year B. Planning undergraduate program is approved and to be applicable with effect from Academic Year 2011-12 (vide Resolution No. 39 and Resolution No. 40). Similarly, the AC and BOG also approved the UG Academic Regulations (vide AC II Resolution No 5 and BOG X Resolution No 43). The above have been complied with, effective from batch AY 2011-12.

In this connection, it is pointed out that for those students admitted prior to AY 2011-12, who are following the old course structure and regulations (of SPA Delhi), and who cannot fulfil minimum academic requirements leading to year-repeat and consequently are required to attend classed with a batch admitted in AY 2011-12 or after, needs to follow 'equivalence course structure and regulations' so that parallel classes of old and new course structure may be avoided or minimised within a same batch of students.

In this connection, an "Equivalence Course Structure and Regulations" was developed and presented before the BOS-Planning in its IV Meeting on July 16, 2012. The matter was discussed at length and after modifications, the BOS-Planning resolved as follows –

"Resolution # 9: The Board confirmed and recommended that the revised "Equivalence Course Structure and Regulations — B.Planning" as presented in Annex II herewith, shall be applicable to students who are admitted prior to AY 2011-12 and are required to attend classes with batches where new SPAV Course Structure (initiated since 2011-12 A.Y.) are followed, due to non-fulfilment of academic requirements or year-repeat."

After elaborate discussions, the AC unanimously suggested that extra classes to be taken wherever equivalence is limited and resolved as follows:

Resolution # 17.

The Academic Council unanimously approves the revised "Equivalence Course Structure and Regulations — B.Planning" as presented in Annex V herewith, shall be applicable to students who are admitted prior to AY 2011-12 and are required to attend classes with batches where new SPAV Course Structure (initiated since 2011-12 A.Y.) are followed, due to nonfulfillment of academic requirements or year-repeat.

To consider and approve certain corrections to the UG-Academic Regulations of ITEM # 6: SPAV, as approved by the AC II and BOG X Meeting.

Chairman informed members that the UG-Academic Regulations of SPAV was approved by AC in its II Meeting (vide resolution 5) and BOG in its X Meeting (vide resolution 43). In this regard, the regulations are currently in effect for B.Planning students who joined from A.Y. 2011-12. It has been observed that the section below of the UG Academic Regulations need correction as below -

Original version:

Section 9.0 Re-registration

9.1 A student who fails to fulfil the minimum academic requirements in any core subject and secures less than 50% marks in the internal evaluation may be permitted the option of re-registering in that subject which will enable him to improve/redo and resubmit the work for internal evaluation.

Proposed Correction:

Section 9.0 Re-registration

9.1 A student who fails to fulfil the minimum academic requirements in any non-core subject and secures less than 50% marks in the internal evaluation may be permitted the option of re-registration in that subject which will enable him to improve/redo and resubmit the work for internal evaluation.

The word core is to replaced with non-core, and the word re-registering is to be replaced as reregistration because the clause 6.3 and 6.4 clearly states in the earlier part of the regulations that reregistration is possible only in failure in non-core subjects. The original version of 9.1 may be treated as a typological error.

After elaborate discussions, the AC unanimously approved and recommended the above change with effect from A.Y. 2011-12, for approval of BoG.

To report the adoption of the "Revised Syllabus based on 1991 syllabus" of 9. ITEM # 7: B.Arch programme of SPA New Delhi w.e.f 2012-13 A.Y.

With reference to the B.Arch programme, Members noted that SPAV has been following all Academic Regulations (including Exam Rules), Course Structure and Detailed Syllabus as prevailing in the mentor institution, SPA Delhi. To this effect, it was reported to the Academic Council vide agenda item no. 9 of the II AC meeting held during 29-30 July, 2011 at SPAV campus.

However, SPA Delhi has revised B.Arch syllabus as well as examination rules and implemented the same w.e.f 2011-12 A.Y. Accordingly, SPAV has adopted the "Revised Syllabus based on 1991 syllabus" of B.Arch programme of SPA, Delhi w.e.f 2012-13 A.Y. The "Revised Syllabus based on 1991 syllabus" of B.Arch programme was placed on table for kind information.

The AC noted the same.

ITEM # 8: To report the list of candidates shortlisted for admission to Doctoral Programme AY 2012-13 of the School by the CDP-SPAV and DRC-Planning and DRC-Architecture.

Chairman informed members that the Academic Council in its II Meeting recommended the adoption of the SPA Delhi Doctoral Regulations (2009) and its revisions from time to time, till Doctoral Programme Academic Regulations of SPAV are formulated and approved (vide resolution #9). Thereafter, the BOG approved the same vide resolution # 47 in its X Meeting held on Aug 05, 2012.

In continuation to that the School advertised for PhD admissions in national dailies and SPAV website on October 19, 2011.
