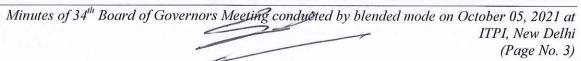
The Director, SPAV requested the Registrar to present the Agenda items for discussion.

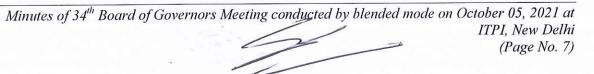
Item#33.4	Establishment of Internal Audit Wing for SPAV with Permanent/Contractual staff.

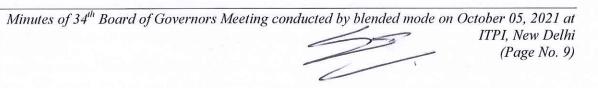
