ITEM NO.1: TO REPORT THE APPOINTMENT OF DR. (PROF.) SHOVAN K. SAHA TO THE POST OF DIRECTOR, SCHOOL OF PLANNING AND ARCHITECTURE (SPA), VIJAYAWADA.

The Director apprised the members that an Order F.No.3-9/2008-TS.VI dated, dated 27th July, 2009 was received from MHRD, Government of India, conveying therein the approval of the appointment of Prof. Shovan K. Saha to the post of Director, School of Planning and Architecture (SPA), Vijayawada in the pay-scale of Rs.18400-22400- (with minimum start at Rs.19400/- pre revised) for a period of five years w.c.f. the date of assumption of charge of the post or till the date of superannuation i.e. 65 years of age or until further orders, whichever is the earliest.
