ITEM NO.1: TO CONSIDER THE RECOMMENDATIONS MADE BY THE BUILDING COMMITTEE AT ITS MEETING HELD ON 8<sup>TH</sup> MARCH, 2010.

(i) To report the matter regarding allotment of land of 7 acres at Govt. Polytechnic, Vijayawada.

The Committee noted the matter regarding allotment of 7 acres of Land at ITI Road, next to Govt. Polytechnic, Vijayawada and also noted that the the possession of land has been taken by the School on 22<sup>nd</sup> February, 2010.

(ii) To consider the proposal for construction of temporary structures and permanent structures towards building SPA(V) Campus, ITI Road (next to Govt. Polytechnic), Vijayawada.

The Finance Committee considered the proposal for construction and temporary structures and permanent structures towards building SPA(V) Campus, ITI Road (next to Govt. Polytechnic) Vijayawada and recommended as under:-

L'Am\_

- (i) The estimated cost of the temporary structure including electrical, plumbing and necessary compound wall etc. of Rs.3.5 crores.
- (ii) The possibility of using present accommodation available at ANU to be utilized for hostels so that all the hostels can be placed in one location for better management and the academic activity could be conducted at Polytechnic location.
- (iii) SPA(V) should pursue the proposal of obtaining 3 acres of additional land from Govt. Polytechnic, Vijayawada as early as possible. It was further mentioned that 28 acres of land at Vijayawada would be available soon in near future. The SPA(V) would attempt to prepare a Draft Master Plan for consideration of the Building and Works Committee incorporating all Institute activities including academic etc. at this Campus.
- (iv) For developing 2500 sqm. of temporary accommodation following steps be followed:-
  - Design specifications should be prepared.
  - DPMT (Departmental Project Management Team) should be constituted.
  - Prequalification by the DPMT Calling of tenders from prequalified Agencies/ Contractors.
  - Appointing PMC [Project Management Consultant)] (outsourcing) for six months.

The meeting ended with a vote of thanks to the chair.
