Agenda Item:

Change of Nomenclature of the PG Program, i.e., M. Plan (Transportation and Infrastructure Planning) to M. Plan (Transport Planning)

This is to bring to your kind notice that the PG Programme, i.e., M. Plan (Transportation and Infrastructure Planning) course, 2-year full time 4 semester course commenced from the Academic Year 2018-19 at Department of Planning, School of Planning and Architecture, Vijayawada. Before the course commencement, a brainstorming session was held on 16.09.2017 to develop the course structure and detailed syllabus by referring the model syllabus of AICTE and other universities. The course title was suggested as M. Plan (Transport Planning) and the same was placed before the Senate for approval.

The Senate in its meeting held on 05/12/2017 and 06/04/2018 suggested the title of the course as M. Plan (Transportation and Infrastructure Planning) and the same was approved by Senate followed by BOG in its 25th meeting held on 27/04/2018 (Annexure I, II and III).

Subsequently, the Department of Planning had submitted an application to Institute of Town Planners, India (ITPI) for course recognition of PG Programme, i.e., M. Plan (Transportation and Infrastructure Planning) on 15/11/2019 and an accreditation fee of Rs. 50,000 was paid by SPA Vijayawada on 19/12/2019 based on the ITPI official correspondence (Annexure IV).

Further, ITPI in its letters dated 22/08/2020 and 03/02/2021 suggested to change the nomenclature of the PG Programme to M. Plan (Transportation Planning) or M. Plan (Transport) referring to the nomenclature in other institutions and recruitment rules of various States/ Central Government (Annexure V).

In view of the above a faculty board meeting and DPGC, Department of Planning meetings were held on 22/03/2021 and after deliberations the committees have come to the opinion to change the nomenclature as M. Plan (Transport Planning) for the benefit of students and suggested to place the matter before the Senate for consideration and approval (Annexure VI). Further, it was also suggested a course equivalence certificate to be used to the passed-out students and a request to ITPI for consideration of the passed-out students equivalent to M. Plan (Transport Planning).

Referring to the above, the matters (a) Change of nomenclature of the PG Programme, i.e., M. Plan (Transportation and Infrastructure Planning) to M. Plan (Transport Planning) and (b) Issue of course equivalence certificate to passed-out students are placed before the Senate for consideration/suggestions and approval.
