Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

### 2. Generic

### 3. Service & Support

### 4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 5. Past Project Experience

- 1. Declaration by the bidder that he /she has not been blacklisted by the Departments/Ministries of the G ovt. of India/State Govt./PSUs in company letterhead in latest date. (Attested copy has to be submitted along with the bid documents).
- 2. At the time of deploying manpower, the Contractor shall strictly comply with all the applicable labour I aws /Acts norms including but not restricted to the age of the workers, conditions of employment and s hall also ensure that a police verification and security check for all the personnel engaged Any default i n complying with the same or any misrepresentation regarding compliance of the same shall entitle SP A Vijayawada to initiate appropriate civil or criminal proceedings regarding the same.
- 3. The Contractor shall not employ any person of age below 21 years and above the age of 50 years and the persons so engaged shall be sound in health capable of performing their work as per instructions an d should not be suffering from any illness, infection and disease.
- 4. The Contractor shall issue necessary identity cards to its personnel and shall keep and maintain a com plete record of all the personnel who are or who shall be assigned any work at the in pursuance of this contract.
- 5. The firm should ensure that the drivers employed are well behaved, reasonably educated, and having communication skills in Telugu and Hindi/English, and conversant with traffic rules/regulations and city roads/routes as well as security instructions.
- 6. The drivers must also observe all the etiquette, protocol and extend usual courtesy (like carrying office bags/files to the concerned chambers, etc.) while performing the duty.
- 7. Contractor shall indemnify SPA Vijayawada from any liabilities arising out of the employment of the m anpower.
- 8. The personnel deployed by the Contractor shall be smartly dressed in neat and clean having Identity C ard containing Photo, Name, Address & date of birth and professional valid driving license.

- 11. SPA Vijayawada shall not provide residential accommodation to any of the personnel/ employee of the Contractor.
- 12. The tenderer may be a proprietary firm, Partnership firm, Limited Company, Corporate body legally co nstituted engaged in car services, who should have required licenses issued by Regional Transport Aut hority (attested copy has to be attached).
- 13. The Contractor shall also obtain and keep in place necessary insurance policies, Mediclaim policies, gr oup insurance schemes of adequate value to cover his personnel, employees with regard to any accide nts, injury or the liability under the Employee Compensation Act.
- 14. No change of driver(s) will be allowed normally without the prior permission of Vehicle –In-charge or SP AV authorities.
- 15. Duration of the service contract may be extended up to 1 year beyond the initial contract duration (su bject to satisfactory performance and mutual consent).
- 16. For outstation night charges -Service provider will be paid Maximum of Rs. 1000- per night if duty hour s end between 11 pm and 6 am at an outstation location (away from HQ).
