- The candidate needs to read this application form together with the Admission Notification for SPOT Round II
  Direct Admissions to SPAV for PG programmes dated 19.07.2024, available at SPAV website.
- ii. Interested candidates shall require to register online for the SPOT Round II <u>latest by 02<sup>nd</sup> August 2024</u> after paying an application fee (non-refundable) of Rs.2,000/- for General/OBC-NCL/EWS categories and Rs.1,000/- for SC/ST/PWD categories <u>per PG course</u> and can be paid through online only. If an applicant is applying to multiple PG Programmes, he/she should pay separately for each programme and register separately for each programme by uploading the proof of payment for each programme separately. Directions for Application Fee Payment is available at https://www.spav.ac.in/spavadmissions.html.
- iii. For online registration for SPOT Round II, after payment, please visit https://spav.ac.in/spavadmissions.html. Online registration has to be completed <u>latest by 02<sup>nd</sup> August 2024.</u>
- iv. Only the candidates who have registered online are required to come in person physically to SPAV campus on the dates of the SPOT Round II, as given in Admission Notification for SPOT Round II Direct Admissions to SPAV for PG programmes dated 19.07.2024.
- v. This application form is required to be downloaded, filled, signed (one original set separately for each programme applied for) and brought physically in person as original hard copy on the days of conduct of SPOT Round II along with all original supporting documents, and self-attested copies of all supporting documents (one set separately for each programme applied). There is no need for send the application form or its associated documents to SPAV in advance by post or email.
- vi. Reservations for all the courses will be applicable for SC/ST/OBC-NCL/EWS/PWD as per rules of Govt of India. Please go through the instructions for applicants of reservation category (OBC-NCL/SC/ST/EWS) as per section E(ii) of the Admission Notification for SPOT Round II Direct Admissions to SPAV for PG programmes dated 19.07.2024. Before applying or registering, for information on exact number of vacancy under each programme and category, please visit https://spav.ac.in/spavadmissions.html
- vii. The candidates pursuing final year of the UG/PG Programme as per eligibility given in 'A' and 'B' in the 'Admission Notification for SPOT Round II Direct Admissions to SPAV for PG programmes dated 19.07.2024 available at SPAV website, can also apply and must submit the CGPA/Percentage of marks secured till the VI Semester (for 4 Years UG Programme) / IV Sem (for 3 Years UG Programme) / VIII Semester (for 5 Year UG Programme) / II Sem (for 2 year PG programme). Such a student is required to submit an undertaking/certificate issued by their institute, certifying that the applicant is 'appearing in final examination of final semester and results would be declared before August 2024. Such candidates, if provisionally admitted, are required to submit final year mark sheets and provisional degree certificate, during the physical reporting at SPA Vijayawada. Candidates who have completed the eligible UG/PG programmes in previous years are required to produce provisional degree certificates, in case the original degrees are not issued.
- viii. The candidates who are employees of a Public Sector Undertaking, a Government Department, a Research & Development organization/lab, a recognized Planning / Architectural Office of repute, can apply under the Sponsored category as per norms of the Academic Ordinances. Such a candidate must have been in employment with the sponsoring organization for at least two years at the time of admission and should submit (a) letter confirming sponsorship, period of employment, and confirming study leave (or extraordinary leave) from the organization for entire duration of studies at SPA Vijayawada, and (b) a No Objection Certificate for entire period of studies at SPAV.
- ix. Application forms, which are incomplete, not signed, or does not have enclosed the required self-attested copies of documents as indicated in the admission notification or the application form, is liable to be summarily rejected. On qualifying Stage-I the applicant needs to appear for Stage II. The School reserves the right to reject/cancel any application without assigning any reasons.
