  4. The Faculty selected for the above posts will be governed by the CCS Conduct Rules, CCS CCA Rules, other Rules and Regulations issued by the GoI from time to time and as per the SPA Act 2014 and SPA Statutes 2016.
  5. The Institute reserves the right to increase or decrease the No. of posts or not to make any recruitment to any post/s, to shortlist candidates for interview and to accept or reject any application without assigning any reason.
  6. The prescribed essential qualifications / experience indicated are bare minimum and mere possession of the same will not entitle the candidates to be called for written test / interview. When number of applications received towards an advertisement is large, the Institute may restrict the number of candidates to be called for written test / interview on the basis of merit or qualification higher than that of minimum prescribed in the advertisement or by conducting test.
