The recommendation of the Committee constituted vide O/o dt.30.10.2024 are placed before the Board for deliberation and consideration. The Point at SI.No.3 of the recommendations, the Board observed that the attached annexure is wrongly placed. The entire amount for completion of the pending works was deposited with CPWD and CPWD assured to complete the work in all respects and handover the same to SPAV within the stipulated time i.e.24.12.2024 and within in the approved cost outlay.

Based on the decision of FC & BoG, the Final Project Closure Report was submitted to the MoE on 11/11/2024 and requested to extend the Project Completion by 31.01.2025.

MoE vide letter dt.29/11/2024 sought clarification on delay occurred in completion of overall campus development project. The detailed statement showing the reasons for delay in completing the campus development projects and its time overrun were submitted to the Ministry on 13/12/2024.

Further the MoE vide its Letter Ref.F.No.5-3/2022-TS.VI, dt.2/01/2025, directed to complete the remaining two un-finished following works within the approved cost outlay and obtain approval from FC & BoG:

- Providing Poly Carbon Sheet covering to Cutouts with MS Framed Structures at terrace of Administrative Building of SPAV.
- 2. Providing 8Nos. Passenger Lifts in the Hostel Building Blocks of SPAV.

1. Covering of Cut-outs at terrace of Administrative Building of SPAV

Providing Poly-carbonate Sheet Covering of cut-outs with MS framed structure at terrace of Administrative Building of SPAV was awarded to CPWD and the work has been completed in all respects and handed over to SPAV on 23.12.2024. The total cost of the work is Rs.68,06,845.00

2. Providing 8Nos of Lifts in the Hostel Building:

The work of installation and commissioning of 08Nos. of Lifts in Hostels has been awarded to CPWD by SPAV with a scheduled completion date of 25/12/2024 as per the contract agreement. At present, testing & Commissioning of Lifts in the Hostels completed in all respect on 23/12/2024 and handed by CPWD to SPAV. The total cost of the work is Rs.1,81,63,155.00

The total expenditure incurred towards Installation and Commissioning of Lifts and Covering of Cut-outs is Rs.2,49,70,000/- (As per Form-65 and Utilisation Certificate submitted by CPWD)

The Project of SPAV has been completed in all respects within the approved cost outlay.

However, as per the directives of the MoE, vide letter F.No.5-3/2022-TS.VI, dt.02/01/2025, the Project Closure Report is being placed before the FC and BoG for kind consideration and approval.

Discussion

It is brought to the notice of the Board about the completion, commissioning and handing over of all the works to the Institute and power point presentation has also been made during the meeting.

Board accorded approval for sending the details to the Technical Bureau of MoE once again for accepting the Closure Report of SPAV Project.

Posting of an Officer/Staff of SPAV in the MoE Item 02 Vide Lr.No.1-03/2024-TS.VI, dt.27.11.2024, MoE requested to post Ms.Neelam Bhat, an employee of SPAV to Technical Section-VI, Dept. of Higher Education, MoE to support the workload of the section for a period of one year or until further orders, whichever is earlier. Accordingly, it is proposed to Ms.Neelam, Section Officer, SPAV to report to TS-VI Section of MoE for a period of six months extendable up to one year as per the instructions of the MoE without any additional pay and allowances. The Director, SPAV may be authorised to release her. Ms. Neelam Bhatt may be advised to carry out the other assignments of SPAV related to DPR 2025-30 (Phase- II), Closure of the SPAV Project and any other work assigned by the Director from time to time. Board accorded approval for releasing Ms.Neelam Bhatt, Section Officer, SPAV to Decision report to TS-VI Section of MoE for a period of six months extendable up to one year as per the instructions of the MoE without any additional pay and allowances. The Director, SPAV is authorized to release her on submission of an undertaking accepting the terms and conditions before relieving.
